The Open Session of this Commission meeting will be held Wednesday, January 13, 2021, at 12:00 p.m. PST and is open to the public. All of the meeting materials including the agenda and a link to register are available on the **ACCJC Open Session event page**.

Anyone can register to attend the Open Session and registration will be open and available through the end of the meeting. However, participants wishing to make a public comment during the Open Session must register no later than January 12, 2021, by 5:00 p.m. PST. Each registrant will be provided the opportunity to indicate whether they would like to make a public comment during the registration process, and if so, must identify the agenda item(s) they wish to address. Please note that no reference to specific individuals or institutions may be made during public comment. Those who are making public comment must either call in by phone or have access to a computer-based microphone to make their comment.
