Last month, I had the great pleasure of participating in my first ACCJC Commission meeting as president and sharing the work of 85 of our volunteers who wrote and reviewed the 2024 Standards of Accreditation, along with all of the public comments accumulated over the past year, which guided the work to make the proposed standards more student, innovation, and equity-focused. The Commission has accepted the first reading and moved forward the currently drafted 2024 Standards. This draft takes into account the feedback received from stakeholders throughout the fall 2022 dialogue process, as well as the Standards Review Leadership Team's work to further streamline processes and reduce redundancies. ACCJC Staff, the Standards Review Leadership Team, and the ACCJC Commissioners appreciate the input and support and look forward to offering the opportunity for continued engagement through the [online comment form](#) and four additional listening sessions scheduled on February 14th and April 18th. The Commission will hold its second, and likely final, reading of the revised 2024 Standards at its June 2023 meeting. 
Please read ahead for more updates on Commission happenings, and thank you to everyone who has participated, and will continue to participate, in this critical Standards review process.

Spring 2023 Election – Announcement of Vacancies

At its January 11-12, 2023, meeting, the Commission announced its spring 2023 Commission vacancies. The vacancies include two academic members; one CIO member with an incumbent seeking reelection; one independent institutions member with an incumbent seeking reelection; one additional Category 1 member; and two peer agency members whose respective agencies have submitted nominees. Each year, ACCJC member institutions submit an Annual Fiscal Report and Annual Report to ACCJC in accordance with the Commission's [Policy on Monitoring Institutional Performance](#). ACCJC uses the data in these reports as it monitors institutions' strengths, stability, and ongoing alignment with the Standards throughout the accreditation cycle. There were no major changes to the questions for the 2023 Annual Fiscal Report or 2023 Annual Report – however, ACCJC staff made several changes to streamline report preparation and improve overall usability of the reporting templates and submission
